

COUNSEL FEES AND FINANCIAL CONTRIBUTIONS DURING THE MARRIAGE

- 14. I invite the Court's attention to my Case Information Statement. There are no liquid assets to borrow against or sell to pay the Defendant's legal fees. All of the vehicles have loans except for a replica Cobra that is in many parts. The source of funds to purchase the replica Cobra was from a personal injury suit resulting from an automobile accident that I had. It is my belief that because it was the proceeds from the automobile accident for pain and suffering that the Cobra is exempt. I do not have any stocks or bonds or a retirement account. I am employee of Millville Family Dental, PA, and I do not own any shares.
- 15. In regard to the marital home, the Defendant is being less than forthright in her explanation of how the house has substantially grown through major renovations during the marriage. I deny that the Defendant paid \$80,000.00 for any of my bills during the first two years of our marriage. It is my recollection that she never made any house payments, car payments, her car insurance payments, utilities or mortgage payments on my office.
- 16. The Defendant has a line of credit with Newfield Bank which was approved approximately two years ago. I have paid the monthly home equity line during the last two years of the marriage.
- 17. When we moved into 2816 Vine Road in February of 2009, it was a one bedroom Cape Cod with a completely unfinished upstairs (bare rafters, studs and floor). The first addition to the home was done by McKenna Construction Company. They put on a new front door and opened the roof upstairs adding three bedrooms, two baths and a sitting room. The Defendant and I did the painting and finishing work including putting down the flooring and doing the walls in the bathroom. The Defendant borrowed from her mother and
